Leave of Absence Requests

We have had many requests for leave recently. Please remember that we are no longer able to authorise leave unless there are exceptional circumstances. A holiday in term time is not an exceptional circumstance as parents are expected to take their children on holiday during the 13 weeks of annual holidays that all schools have. If you do take your child out of school without authorisation then the school is legally required to pass this information on to the Local Authority.

- The Local Authority may then issue a penalty notice and fine you on the first occasion (Pay £60 within 21 days of receipt of the Penalty Notice; Pay £120 between 22-28 days of receipt of the Penalty Notice)
- The penalties for taking children out of school a second time have increased quite dramatically and now, only one Penalty Notice will be issued within a two year period. If you take your child out of school again, within this two year period without authorisation, you are likely to be summonsed to Court and, if convicted, you could receive a fine of up to £1,000.
- If you are convicted and take your child out of school again within the next five years, you will be summonsed to court and if convicted, you could receive a fine of up to £2,500 or up to 3 months imprisonment.

Our Attendance Policy is on our website and we would draw your attention to the fact no leave of absence will be authorised in September (a crucial time in school for children to settle in to their new classes) or May (a crucial time in school with many statutory tests taking place).

General Data Protection Regulation! (GDPR) If you are like us, your inbox has been bombarded with companies seeking your consent to continue contacting you! As a school we must comply with all the new regulations that came into effect from 25th May. The point of GDPR is to make sure sensitive or private information about yourselves and your children stays safe. Whilst it is similar to the current Data Protection Act in many ways, there are a few differences, so we need to make a few changes at the school in order to ensure we remain compliant. We have appointed an external Data Protection Officer who will help us achieve compliance with the new regulations. We have also published a new Privacy Notice which will outline how we use your data. You can find this on our website in the GDPR folder in our 'About the School' section. You will also find information on how long the school is required to keep your data and how we dispose of it in our Record Retention Schedule.

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you about the variety of communications you can choose to receive from the school and offer options for you to consent to, or not, with regard to your child. Even receiving this newsletter will become something you will have to opt in to. If you opt out, we will continue to publish the newsletter on our website so you can access the information there. Please watch out for the information we send home regarding staying in touch. We will only ever send you information we believe is in your child's interest.
